Purposes of the processing and legal basis

We process your personal data exclusively for the purpose of contacting you. If you have consented to communication via a newsletter, this is also the purpose of the data processing. Should further processing take place through further cooperation with you, the processing will take place in this context.

The legal basis for the processing of your data is Art. 6 DSGVO para (1) lit. a). Further processing in cooperation has as its legal basis Art. 6 DSGVO para. (1) lit. b).

Transfer your data within the company

Internally, the persons responsible for carrying out the contact procedure in the respective departments as well as the persons from the respective specialist departments concerned will have access to your data insofar as this is necessary for the decision on further cooperation.

Storage duration

We will only store your personal data to the extent and for as long as it is necessary for the purpose for which it was collected by us or provided to us by you. After the purpose of storage has ceased to apply or a statutory storage period has expired, we will delete your personal data in accordance with the statutory provisions.

Your rights

You have the following rights under the GDPR:

- Right to information (Art. 15 GDPR)
- Right to rectification (Art. 16 GDPR)
- Right to erasure (right to be forgotten) (Art. 17 GDPR)
- Right to restriction of processing (Art. 18 GDPR)
- Right to data portability (Art. 20 GDPR)
- Right to object (Art. 21 GDPR)
